# Portugal Immigration

*D2, D7, D8 and Golden Visa residency pathways for UAE residents*

Portugal offers structured residency pathways for UAE residents through multiple visa options tailored to different profiles — starting a business, living on passive income, working remotely, or investing. Reliance Immigration assists in identifying the right pathway, preparing documentation, and ensuring compliance with current requirements.

## VISA OPTIONS

### Portugal D2 Visa

For entrepreneurs and business owners planning to establish or expand a business in Portugal.

### Portugal D7 Visa

For individuals with stable passive income such as pensions, rental earnings, or dividends.

### Portugal D8 Visa

For remote professionals and digital nomads working for companies or clients outside Portugal.

### Portugal Golden Visa

Investment-based residency with flexible stay requirements and access to the Schengen region.

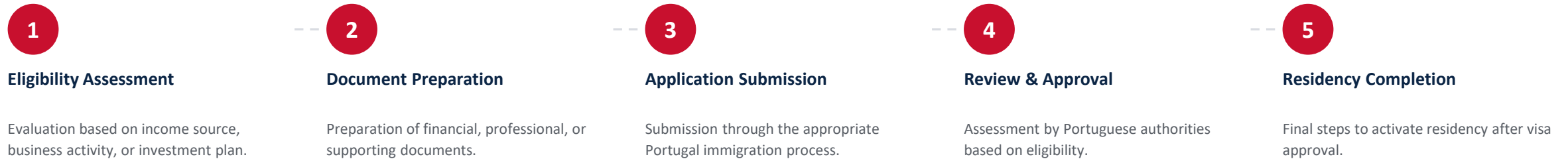
## WHO CAN APPLY

- Passive income applicants — rental earnings, pensions, or dividends
- Entrepreneurs and business owners establishing or expanding in Portugal
- Remote professionals working for companies or clients outside Portugal
- Investors seeking residency through the Golden Visa route
- Families and long-term relocators seeking EU residency

# Portugal Immigration

*From eligibility assessment to residency completion*

## APPLICATION PROCESS



## DOCUMENTS REQUIRED

- Proof of financial stability or income source
- Passive income proof (for D7 Visa applicants)
- Remote work contracts or proof (for D8 Visa applicants)
- Business plan (for D2 Visa applicants)
- Investment-related documents (for Golden Visa applicants)



# Spain — Digital Nomad Visa

*Live and work remotely in Spain with a structured path to long-term residency*

The Spain Digital Nomad Visa allows non-EU professionals to legally live in Spain while continuing their remote work or international business activities — designed for individuals seeking long-term residence and lifestyle stability in Europe.

## MINIMUM MONTHLY INCOME REQUIREMENTS

| <b>Main Applicant</b>       | €2,762 / month (approx. AED 12,000)         |
| <b>First Dependent</b>      | + €888 / month for spouse or partner        |
| <b>Additional Dependent</b> | + €296 / month per extra child or dependent |

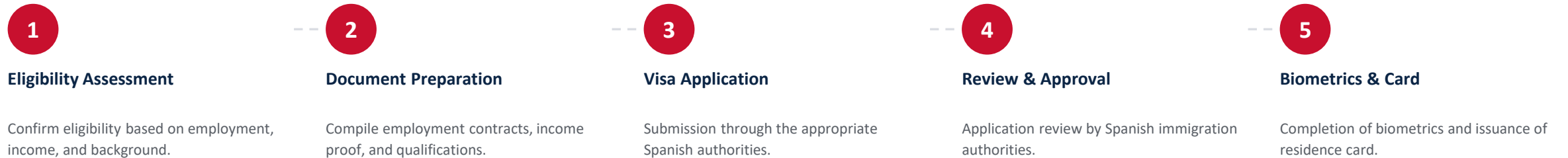
## WHO CAN APPLY

- Remote workers and freelancers from non-EU nations working for foreign companies
- Employees of a company outside Spain, continuing under an existing contract
- Freelancers with ongoing professional activity and stable client income
- Applicants with a relevant degree, or minimum 3 years' relevant work experience

# Spain — Digital Nomad Visa

*From eligibility assessment to your residence card*

## APPLICATION PROCESS



## DOCUMENTS REQUIRED

- Proof of ability to work remotely from Spain
- Evidence of professional qualifications or relevant work experience
- Valid employment contract or client agreements outside Spain
- Proof of stable income from foreign sources
- A clean criminal record certificate

# UK Immigration



*Skilled Worker, Innovator Founder, and Expansion Worker visa routes*

Reliance Immigration provides structured UK immigration and visa support for UAE residents looking to relocate to the United Kingdom through eligible pathways — covering eligibility assessment, documentation preparation, and application guidance.

## VISA OPTIONS

### UK Skilled Worker Visa

Requires a job offer from a UK-licensed sponsor and meeting salary and eligibility criteria.

### UK Innovator Founder Visa

For individuals with innovative business ideas approved by a UK endorsing body.

### UK Expansion Worker Visa

For applicants associated with companies expanding their operations into the UK.

### Family Sponsorship Routes

Eligible applicants can include dependents under most UK visa categories.

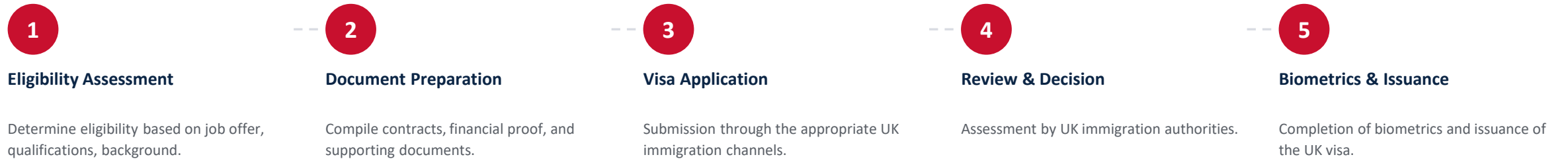
## WHO CAN APPLY

- Skilled professionals with a valid job offer from a UK-licensed sponsor
- Employees of organizations expanding their operations into the UK
- Applicants who can demonstrate financial stability per UK visa guidelines
- Qualified professionals and graduates aligned with UK job market demands
- Business and innovation applicants eligible for UK endorsement

# UK Immigration

*From eligibility assessment to visa issuance*

## APPLICATION PROCESS



## DOCUMENTS REQUIRED

- Job offer letter from a UK-licensed sponsor (Skilled Worker Visa)
- Certificate of Sponsorship (CoS)
- Proof of qualifications or relevant work experience
- Bank statements or proof of funds
- Police clearance certificate

# Brazil Residency

*Investment, business, employment, retirement and skilled-professional pathways*



Brazil is steadily gaining attention among UAE residents looking for a second residency outside the Gulf and Europe — the largest economy in Latin America, with a growing investment landscape and an established framework for foreign residents.

## RESIDENCY OPTIONS

### Investment Route

For individuals making a qualifying investment — real estate, financial assets, or other approved categories.

### Business Investment

For entrepreneurs establishing or investing in a Brazilian company.

### Employment-Based

For professionals with a confirmed employment offer from a Brazilian company.

### Retirement & Skilled Professionals

For qualifying retirees and applicants with specialized qualifications or experience.

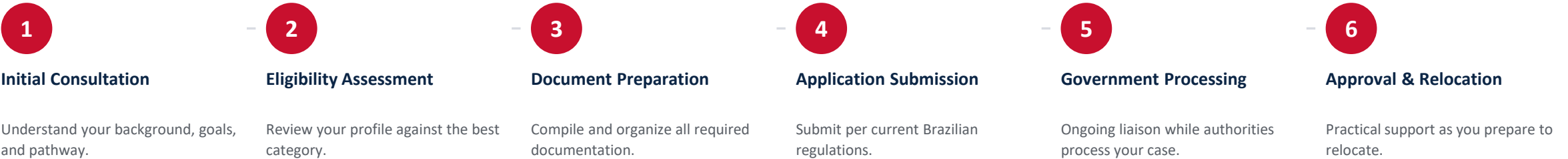
## WHY BRAZIL

- Largest economy in Latin America, with a large and growing domestic market
- Expanding investment sectors — real estate, agribusiness, technology, and energy
- Cost of living considerably lower than the UAE or Europe in many cities
- Access to Mercosur, supporting regional mobility and trade
